ORDINANCE SPOTLIGHT

CHAPTER 96 Rights of Way; Streets §96-2. Paving; Obstructions limited; Permission for changes (Street right of way is 70 feet)

- New paving or change of materials of any right of way in Henlopen Acres by any person other than the Town, is prohibited.
- Obstructions and/or intrusions, including timbering, borders, landscaping, plantings, and reflectors, in any part of the right of way by any person other than the Town is prohibited.
- Application for permissions.
 - 1. Any property owner may apply to the Commissioners for permission to change materials in an existing driveway connection or install new paving or create a new driveway connecting a lot to the paved portion of the Town's right of way by filing an application for building permit; provided, however, that installation of a new driveway as part of new construction or improvements shall be reviewed only as necessary as part of an Environmental Approval Committee review process and approval. [Amended 4-12-2013]
 - 2. Any property owner may apply to the Commissioners for permission to use part of the right of way for improvements for parking and landscaping, by filing an application for a building permit.

At the January Commissioners meeting, the Board awarded the last phase of paving to Utilisite from Lewes. The last phase is scheduled to be completed this spring prior to May 15. The work includes paving of Zwaanendael from Henlopen Ave to Rolling Road and Broad Hollow from Pine Reach to Rolling Road.

Ocean Outfall

You are probably aware of the Rehoboth ocean outfall project. It was recently reported that the pipeline construction would close Henlopen avenue for two months. This is not accurate. The street construction will take two months but only closing a block at a time. Work is not expected to commence until 2017 and should have little effect on your access to the Acres.

Marina

CATS – Cats that go outside must wear identification of rabies vaccination. Unidentified cats may be apprehended by town personnel, at their discretion.

SQUIRRELS, RACOONS, OPOSSUM – Town personnel, at their discretion, may attempt to trap and relocate animals causing damage.

ALL OTHER NUISANCE ANIMALS – Residents must call a private contractor licensed by the State of Delaware. A list of licensed contractors is available at:
