The Board of Commissioners of the Town of Henlopen Acres held their annual **Organizational Meeting on Friday, September 12, 2025, at 10:00 a.m.**, virtually and in person at Town Hall, 104 Tidewaters, Henlopen Acres, Delaware.

The meeting was called to order at 10:00 a.m.

# 6. <u>Discussion and possible action on approval of final 2025 Comprehensive Plan in accordance with 22 Del. C § 702(f)</u>

#### **Motion:**

Commissioner Staffier made a motion to approve the final draft of the 2025 Comprehensive Plan. Commissioner Richards seconded the motion, and it was unanimously approved.

# 7. Town Manager Report

Town Manager Anna Fagan reported that recent technical failures at the water plant necessitated the use of the City of Rehoboth Beach interconnect four times this year. As a result, the City of Rehoboth Beach is requesting that a meter be installed to track usage so that they may bill the Town based on usage. Ms. Fagan requested approval from the Commissioner to allocate funds for this purchase.

#### **Motion:**

Commissioner Staffier made a motion to approve the funds for the purchase of a water meter to be installed at the Town's interconnect with the City of Rehoboth.

Commissioner Derrickson seconded the motion, and it was unanimously approved.

Ms. Fagan reported that the PFAS remediation feasibility study conducted by KCI Technologies was largely complete. The study recommends installing granular activated carbon (GAC) equipment, with an estimated cost of \$400,000. Alternatives, such as relying on Well 11 and collaborating with Rehoboth Beach for additional water supply, were discussed. The Town expects funds from the class-action PFAS lawsuit to partially cover costs, with further water sampling and concept plans forthcoming.

Ms. Fagan presented the Treasurer's Report. The Town recovered \$6,500 from fraudulent ACH debits on its general checking account and transitioned to a new account for security. Property tax collection is nearly complete, with only nine payments outstanding, totaling \$36,000. Grant revenues from Sussex County, the state, and other sources were highlighted, with zoning and construction fee revenues on track to meet targets.
